An active participant refers to a person who regularly participates in the activities of the association/action group/department or similar. Regular activities can include clubs, meetings, camps and organisation of events. Participants who have participated as members of an audience or who have participated occasionally do not count as active members.

2. Young people s participation times in the activities of the association

2a) All participation times of persons under 29 years of age in the previous calendar year

Enter here the total number of participation times for the year preceding the application. For example, if you are applying for a grant for 2024, enter the figures available for 2023.

The figure indicates the total number of times persons under 29 years of age have participated in the activities of your association/group during the previous year.

Activities refer to the activities of the association throughout the year, such as clubs, courses, camps, events and performances. If the activity lasts overnight, it counts as only one event, such as a camp lasting several days and nights. Day camps lasting more than one day are also counted as one event.

A participation time refers to every participant of every event, session, activity or similar.

You can only enter one figure. This figure also includes digital attendance.
